# Minister's Musings

"To everything turn, turn, turn There is a season turn, turn, turn And a time to every purpose Under heaven:

The Bryds



"For everything there is a season, and a time for every matter under heaven." Ecclesiastes 3:1

I have been musing on these two quotes lately thinking about what it means to have beginnings, middles, and ends. We understand that life follows this plan and we work our way through each of these stages in our lives, but as I thought about the song by the Byrds, I recognized that these stages sometimes come around time and time again. As I thought about this I realized that quite often within each one of these three stages are also small endings; with letting go of thoughts and feelings, ways of doing things, or death of some of those things that we always knew. Then there are similarly new beginnings; new ways of doing things, new thoughts, or a rebirth of energy and passion. This past year at Windsor Park United Church we have had our fair share of these stages.

Each year, we, as a community, work our way through the grief of losing members of our beloved community and 2018 was no different as we lost a number of beloved members of the Church. Yet, as a community, we learn to start again living in a new reality. We continue to remember and celebrate the impact that those we have lost have had on our lives.

As spring came around I found myself at the end of my time at theological college as graduation and ordination were completed. It was only through the love, patience, wisdom, support and care of this community that I was able to complete all the requirements and be ordained and called to ministry at Windsor Park United. That one journey came to an end and we all have embarked on a new journey together.

This past year we also celebrated the 60th anniversary of the founding of Windsor Park United Church. We hosted a potluck supper at the Church on the first Saturday in November and then our service of celebration the next day on Sunday morning. It was wonderful to see so many familiar faces, those we have seen often, those we haven't seen for a time, and everyone in between. As we celebrated this milestone in the history of the community, we also see this middle time as a time to begin again. We look to re-imagine our place in the world as we applied for two separate grants from the Winnipeg Foundation, one to help us work towards a new way of being in the world. Looking at ourselves as a community hub, a place where the local community sees us as engaged in their daily lives. The second grant helping us to continue to move forward in our journey of reconciliation with our Indigenous brothers and sisters, building on the work that we began with the Rev. Stan McKay and the Bear Clan. As a community when we look back over the past years we will each find those places of endings and new beginnings.

This past year was also a time of ending and beginning for the whole church. With our changing structure we had to let go of Presbytery and Conference, parts of our history that have been with us since the founding of the Church in 1925. With this ending, we move into a future of new beginnings and with decisions still needing to be made, we move into the future that might seem rather unsettled. No matter what the future brings the wider church, we at Windsor Park United Church will continue to journey through all of our beginnings, middles, and ends together.

It has been a blessing to be called to Windsor Park United Church as your Ordained Minister. It is a blessing to journey with each and every one of you through our beginnings, middles, and endings. I offer my sincerest gratitude to each of you for this past year, all of its joy and celebration, struggle and grief. We all find ourselves to be a part of a special community, one that is willing to learn and grow together. We have been blessed with the company of many saints in our midst and may we continue to have these blessings in our lives as we move through the stages of our lives, both individually and as a community.

# OFFICIAL BOARD

We made some new memories in WPUC's 60<sup>th</sup> anniversary year. In January, Presbytery accepted our recommendation to hire Patrick as our "new" minister. For those involved in the Ministry Profile Committee, it was quite a journey. It didn't end until the covenanting service on November 4<sup>th</sup>. That was also our Homecoming weekend that included a very well attended Potluck Supper and many old friends in attendance at the Sunday morning service.

Presbytery and Conference are now a memory, they were dissolved in December and replaced by Region 5 which is going through some birthing pains. Its first General Meeting is later this spring.

We also assembled another pictorial directory so our memory of faces would stay fresh, starting with the photographer sittings in May, draft submission and edits over the summer and final delivery in the fall. Not as many pages as previous directories. Stained-glass windows in memory of Angela Moodie and Thelma Mallard were added to the sanctuary. Please review the Passings section of this report to reflect on those who will be missed as well as the Baptisms on those who represent the future.

We wanted to tell the neighbourhood "All Are Welcome". We wanted to let the neighbourhood know that we are more than just a Sunday service and it is OK to climb our steps on any day; thus, the Little Free Library (LFL) was installed with the generous time and talent of Dana Stockwell and Laurie Ringaert. Many thanks to Sue Turley for keeping the LFL tidy and well-stocked with a diverse selection of reading material.

Our Winnipeg Foundation grant application to assist with roof repairs / refresh was approved for \$20,000. This will allow us to use our time, talent, and treasure to pursue other initiatives like a "Hub coordinator", a part-time position to connect with other institutions in our neighbourhood to let them know we have meeting space and a full kitchen. The coordinator will also seek out those who have a message that needs to be heard – social justice, dealing with health issues, understanding our changing neighbourhood demographics, etc. This should result in new memories to be created by our neighbours that we may not know at this time.

## **BOARD OF TRUSTEES**

We now have guidelines for the installation of stained glass windows. The guidelines were prepared by the Trustees, and approved by the Executive Team. There are still several windows available for such installation, with initial approval to be granted by the Official Board.

As part of our annual review of the WPUC insurance coverage the Trustees discussed the coverage for the stained glass windows. At the time of discussion, 2 windows were yet to be installed, so a decision was made to leave coverage as is, with increases to be made in future. The appropriate forms for insurance coverage were signed.



We are in the process of complying with the request from Wood Gundy for additional information about the Trustees as signing authorities for the WPUC investment policy. Wood Gundy also requires official notification of the membership of the Board of Trustees, which will be addressed at the AGM. The annual Child Abuse Registry was completed, as begun by Angela Moodie.

As usual, the Trustees assembled the interim and final income tax statements and assisted with their distribution.

The Pop-up Choir proved to be popular this year, making it possible for retired choir members and those who are unable to sing on a regular basis to join with the Worship Choir to lead the music in worship and sing an anthem or two. We were delighted that the choir loft was full on Christmas Eve with our first Christmas Eve Pop-up Choir!

New singers are welcome in the Worship Choir at any time of year. We are currently both male and female voices, but especially need men to come forward for the choir so that we are able to do more 3 and 4-part singing. After a winter break, they resumed practicing in the early spring with 9 children. Practices were held each Sunday until Easter, and the Joyful Noise sang in worship on both Palm Sunday and Easter Sunday. After summer break, the group began having practices every second week starting in October to get ready for Advent and Christmas. Five beautiful young voices sang at the Christmas Concert held on December 9, and on White Gift Sunday all of the children in Bible Adventures sang together in worship. The Joyful Noise continues to practice every second week and encourages any young person up to age 12 to join them!

During 2018, the Praise Team continued to offer leadership and music with a contemporary flavor. Praise Team services were held on January 28, March 11, June 3, October 21 and December 16. 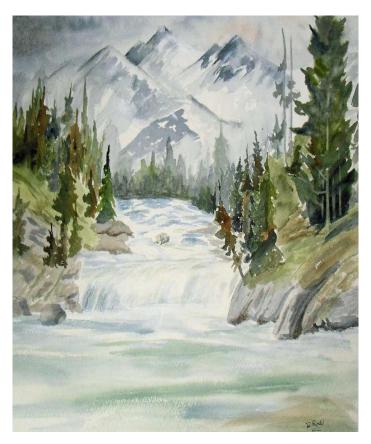
# THE STAMP BOX (situated in the drawer at the back of the Sanctuary)

## **OUTREACH COUNCIL**

Your Outreach Council has been involved in a variety of activities throughout the past year. Our efforts support West Broadway Community Ministry, the Winnipeg Cheer Board, and individuals and families within our community.

With help from friends in the WPUC congregation and the community at large, we contribute regularly to the lunch program and emergency pantry that is offered at the West Broadway facility. Shirley and Gord Goossen regularly collect donated items from our church and transport these to the staff at WBCM for use with their guests. We prepare and serve monthly lunches for approximately 180 guests at WBCM. We gratefully acknowledge the steady supply of baking and produce, as well as the donations of time, expertise and finances that enable us to provide a hearty meal and cheerful company to people in need. On several occasions, Judi Olson-Chiswell has shared her time and talent to cut clients' hair on site while WPUC is serving them lunch. Staff and management at Southdale Co-op have also given financial support or gifts-in-kind for some of our recent lunches at WBCM.

In the spring, we assisted with meal preparation and clean-up for the WBCM Volunteer Appreciation Supper. During the summer when support for the ministry tends to wane, we doubled our efforts and provided 4 lunches to the guests. Before Christmas, we filled a request for warm socks that were presented as gifts to people attending the WBCM Christmas supper.

In our immediate neighbourhood, some members of our council have participated in two blanket-making bees organized by the Prince of Peace congregation. Approximately 40 fleece blankets were made for Morberg House, a facility which provides shelter and support for homeless individuals in the St. Boniface area.

With surplus funds from our 2017 Christmas Hamper project, we purchased a grocery gift card in lieu of an Easter Hamper and presented it to Hanifa Malik, a Pakistani refugee whose family was most recently sponsored by WPUC. A second gift card was also given to the family during the summer to assist them with back-to-school expenses.

In December, we once again participated in the Feed-a-Family program organized by the Christmas Cheer Board. Hampers for 21 families and pensioners were packed and delivered. We gratefully acknowledge the UCW Unit 2 for



providing gifts for all adults who were hamper recipients and to the Bible Adventures' families who provided the childrens' gifts.

Our Mitten Tree looked particularly stylish this year. Draped lovingly amongst and beneath its branches were over 150 winter accessories. We thank the avid knitters – and shoppers- from our own congregation, as well as the Seine River Apartment Knitting Group, for their generous donations to this endeavour. All of the items have been transported to Rossbrook House for distribution to the children who can access that facility 24 hours a day 7 days a week.

Looking back at what has been accomplished by so many caring individuals is very heartening. It also encourages us to move ahead with continued optimism and energy.

## WINNIPEG PRESBYTERY - HIGHLIGHTS OF 2018

**February** – The General Meeting was held at The United Church in Meadowood with co-hosts of the meeting being McClure United Church, Charleswood United Church, Trinity United Church and Oak Table Community Ministry. Judy Hare, the Conference Personnel Minister, presented an update on the Sexual Misconduct Prevention and Response Policies and Procedures and an Introduction to the Workplace Violence and Harassment Policy. Winnipeg Presbytery also elected the following representatives to attend General Council 43 in Oshawa on behalf of Winnipeg Presbytery: Lay Commissioner – Nancy Renwick; Ordered Commissioner – Loraine MacKenzie Shepherd. Loraine MacKenzie Shepherd shared a PowerPoint update on the Winnipeg Indigenous Accord.

March – Our General Meeting was an all-day meeting held at Sturgeon Creek United Church with co-hosts of the meeting being Crestview United Church, Kirkfield Park United Church, Silver Heights United Church, St. Charles United Church and Headingley United Church. The Truth & Reconciliation Commission Response Group (TRC) of Winnipeg Presbytery presented an interactive quiz named U.N.-Dripardy. Betty Kelly, the Conference President, presented an update on the transition taking place in the United Church and the phasing out of Presbyteries. Group discussion took place around the following questions: what things would be missed; what things would be looked forward to; what are the priorities of Winnipeg Presbytery that we would like to see carried forward in the new structure.

**April** – The April General Meeting was held at Harrow United Church with the cohosts of the meeting being Westworth United Church, Fort Garry United Church and Crescent Fort Rouge United Church. The Conference Annual Meeting Planning Committee updated the court on the plans for the annual meeting taking place May 24-27 at the University of Manitoba. A video presentation of Iridesce: The Living Apology Project was presented to the court. Tessa Blaikie Whitecloud was nominated as a candidate for Moderator for consideration at General Council 43 in Oshawa.

May – Our General Meeting was held at Broadway Disciples United Church with co-hosts of the meeting being Knox United Church, Young United Church, Augustine United Church and West Broadway Community Ministry. The Young Adults & Youth Committee (YAAY) gave an update to the court on their recent activities. Winnipeg Presbytery bid farewell to Richard Manley-Tannis, the Winnipeg Presbytery Minister of Evangelism, Mission & Church Development, as he accepted the position as Principal at St. Andrew's College in Saskatoon.



June – The June General Meeting was held at St. Andrew's River Heights United Church with co-hosts of the meeting being Atlantic-Garden City United Church, Sparling United Church and Kildonan United Church. A Transition Report was given updating the court on the move to the new structure. We acknowledged the following retirees – Joanne Kury, Milly Malavsky, Bill Millar, Bill Blaikie and Jim Christie. The TRC Response Group encouraged congregations to become signatories to the Winnipeg Indigenous Accord since Winnipeg Presbytery would be ending at the end of 2018. Sherri McConnell was installed as the new Presbytery Chair.

**September** – Our General Meeting was held at Immanuel United Church with the co-hosts of the meeting being John Black Memorial United Church, Gordon-King Memorial United Church and North Kildonan United Church. The YAAY Committee updated the court on recent activities of the youth in the conference. The TRC Response Group gave an overview of their activities. Joan Jarvis, the Conference Relations & Social Justice Minister, updated the court on the work to date of the Transition Commission. Table discussion was spent discussing what was seen across the church or in each Presbyter's church that could be transitioned into being a network or cluster.

**October** – The October Meeting was held at St. Mary's Road United Church with the co-hosts of the meeting being Churchill Park United Church and Korean United Church. A motion regarding Winnipeg Presbytery's recommendations on the proceeds from the sale of church properties was approved. This motion was forwarded to Region 5 Commission. Those from Winnipeg Presbytery who attended GC43 updated the court on GC43. The issue of racism in the church was discussed.

**November –** Our November Meeting was held at Windsor Park United Church with the co-hosts of the meeting being Transcona Memorial United Church, Grey Street United Church and Westminster United Church. Representatives from the YAAY Committee updated the court on the recent activities of the youth in the conference. The Affirming Group as well as the Intercultural Group of Winnipeg Presbytery gave overviews of their activities. Invitations were given to churches to become involved in these groups as well as an Ecumenical/Interfaith Relations cluster.

**December** – A dinner for Presbyters was held prior to the final Winnipeg Presbytery meeting at the United Church in Meadowood where financial transition and closing motions were made. Winnipeg Presbytery bid farewell to Maggie Zoske, the Winnipeg Presbytery Administrator. A final worship service of Winnipeg Presbytery was held which celebrated the past and embraced the future.

## **FINANCE & STEWARDSHIP**

#### Stewardship is Time, Talent & Treasure

#### Time

Time is Money. We've all heard this a thousand times. What is my time worth? When it comes to Stewardship time is part of a larger whole. It is a collective, it builds, it multiplies and becomes an immeasurably valuable tool. How best can I offer my time even though it may be limited and sporadic?

Well... Come oooon down! Here's just a taste of possible ways to offer your time at WPUC:

- Be a Greeter or Usher
- Help at Sunday coffee (you don't need to be on a council!)
- Join the offering counters team
- Act as a Communion assistant
- Do the Liturgy reading on Sunday
- Stand for a Council position (the more people on a council reduces the commitment required)
- Volunteer at Tot Time
- Assist at Bible Adventures
- Prepare for and clean up after church events e.g. Spring dinner, Cookie walk etc.
- Be an Outreach visitor to our shut ins
- Christmas hamper team, packing, driving, purchasing, tracking receipts and accounting
- Crew for spring property and parking lot clean up

There's much more, so step forward and say "Put me in Coach. I'm ready to play!"

#### **Talent**

You have never won American Idol? So, this means you ain't got no talent. WRONG! Talent is not just one dimensional. It is the sum of all your interests, skills, ideas, expertise, career and life experience. Honestly, you have much to offer. OK, how can my talent become an asset for WPUC? Here are some avenues you can take to make your talent available. Remember, there is no age limitation; youth and maturity are equally valuable.

- Participate in church decision making. Councils and teams are thirsting for new ideas and approaches for our programs and services. Your input will carry our church forward.

- People skills and schmoozing. You have met all kinds of people and attended various events. You may have the knack to pick someone's brain for ideas and concepts and bring them back to WPUC. As an example, the Women's Heart Health seminar was a huge success.
- Pop-up Events. Offer workshops, seminars or get-togethers showcasing
  your interest in gardening, cooking, crafting, history, music, hobbies, art or
  sport. This just a short list of possibilities. Note that these do not necessarily
  need to be held at the church but could be arranged at another place
  or venue.

I hope this presentation gets your juices flowing and inspires you to offer your talent to our congregation and community. Don't hide your light under a bushel! Your engagement in church life is critically needed to ensure that WPUC will remain an involved, caring and meaningful participant in our community for years to come.

#### Treasure

As a member of the congregation, how much should I give to support our church and community?

The chart below may help you picture where WPUC stands and where you fit in as a valued giver.

#### What do these numbers mean?

It is evident that our revenue from Envelopes, PAR and Open offering is on a declining trend. Other fund raising and one-time donations can have a positive effect, but the heart of our church's revenue is from regular offerings. At the same time, our various councils (Property, Christian Development, Outreach, Ministry & Personnel, Worship, Membership & Pastoral Care and Finance & Stewardship) have worked hard to be efficient and cost effective in reducing expenses. However, there is a limit to cost saving since our basic overhead (salaries, administration, insurance, maintenance & repair and utilities) must be met and more reduction would then have to come from our church programs and community services.

We can see how the **Average** yearly giving amount has fluctuated over the years. This is only one way to look at congregational giving and is easily skewed by one or two very large donations or by many smaller donations. It would be easy to assume from a high average that people are giving at a higher level than is true. A more meaningful way to look at this may be the **Median** amount given. The Median represents the amount at which half the donors gave more, and half gave less. In 2018 our Median amount was \$360.

What will the numbers look like at the end of 2019?

Our Stewardship challenge for 2019 is to reverse the declining trend and put WPUC on a sustainable footing. How can we do this? One option is for each of us to look at our givings and see if we can increase our PAR or Envelope amounts by 5%. A 5% increase to our 2019 budget of \$160,200 would add \$8010 to our revenue. Another option is to invite those givers at or below the Median amount to approach, match or exceed it as best they are able.

As a congregation, our hope and expectation is for Windsor Park United Church to flourish for many years to come. We must ask ourselves "Will our church be around for me when I am in need"? For the answer to be "Yes" we ought to look



carefully at the **costs** required to run our church and weigh them against the astounding **value** we receive in return. If we want to ensure that Windsor Park United Church's faith community and programs continue, let's practice the "Pay it forward" approach to Stewardship. Another sixty years? **You betcha!**
